Step 1:

To apply for personal data about yourself or the data subject under the Personal Data Protection Act 2010 ("data"), please complete this form. Please describe the data being sought or to be corrected, and provide any relevant details necessary to help us locate your data.

Step 2:

Print the Personal Data Access/Correction Request Form, fill in the requested details and email to safarina@ijn.com.my, together with the additional documents (if any).

Important Note:

- 1. The data provided will be used for processing your request on access/correction data. The provision of personal data is voluntary. However, if you do not provide sufficient data, we may not be able to process your request.
- 2. If the request is made by an individual other than the data subject, please also submit:
 - a) An authorization letter signed by the data subject;
 - b) Proof of identity of the data subject e.g. copy of IC, driver's license, employee ID; and
 - c) Proof of requestor's relationship with the data subject e.g. marriage certificate, birth certificate.
- 3. You may be asked to provide additional information to help us process your request.
- 4. Data subject means individual who is the subject of the personal data.
- 5. We may charge a prescribed fee for processing your request for access/correction data on the following charges:

Personal data with copy	RM10.00
Personal data without copy	RM2.00

The supporting document(s) required in this Form must be provided and the relevant processing fee paid. We will respond within 21 days of receipt of the completed Form with accompanying documents and payment.
